 - Adam Street
 GWNI continue to look at meanwhile use for the site.
 - Alexandra Park

 - Hillman Court

KC stated that this has led to some residents reconsidering need for wall. Meetings continue with NHA/NIHE regarding land transfer with NHA not taking ownership until issues are complete, for reassessment in 6 months time.
